Submission Guidelines

1. The manuscript submitted must be MS Word format, typed in Times New Roman, font size 12 with 1.5 line spacing and contain the title, name of author(s), affiliation and detail contact information of corresponding author.
2. The length of abstract should not exceed 250 words and it shall include 4-6 keywords.
3. Full length papers should be between 4000- 6000 words including reference, notes, tables and graphs etc.
4. Follow ILI citation for legal discipline and for other academic disciplines, follow APA style of referencing.

5. All works must be original and unpublished and must not be pending for review.
6. Manuscript will be thoroughly evaluated by a screening committee on a set of criteria including quality of the content and subjected to plagiarism test.
7. Selected articles will undergo peer review and be compiled and published in an edited book with ISBN.
8. Sending email at gmlcnationalseminar@gmail.com is required for all submissions.
9. Co-authorship of up to three authors is permitted. However, individual registration is mandatory for author as well as co-authors.
10. The organizing committee is not responsible for any copyright infringement by the author.
11. The copyright for all entries shall vest with the organizers who herewith reserve the right to modify the contribution as per the requirement.
