

## MEMORANDUM OF UNDERSTANDING / AGREEMENT

The Memorandum of Understanding is signed on the 20<sup>th</sup> June, 2020 Between the Mizoram State Legal Services Authority and Govt. Mizoram Law College, for promotion of Legal Awareness and Legal Literacy and to eradicate legal problems by means of mediation and conciliation in the State of Mizoram and assist the Law Students and faculty of Govt. Mizoram Law College towards their academic pursuits.

These are the points of agreement:

1. Govt. Mizoram Law College shall provide facilities like rooms and other amenities within its campus for the establishment of Legal Cell in the College.
2. Mizoram State Legal Services Authority shall provide Advocate and Para legal Volunteers to assist the working of the Legal Aid Clinic as required.
3. Mizoram State Legal Services Authority shall entertain Law Students in performing their Internship assignments from time to time.
4. The Faculty members of Govt. Mizoram Law College shall make their Services and experiences available as resource persons to the Service of Mizoram State Legal Services Authority, when called for.
5. Mizoram State Legal Services Authority and Govt. Mizoram Law College shall organize in joint hands, program like Seminars, workshops, Legal outreach, etc. as mutually agreed, from time to time.
6. Mizoram State Legal Services Authority shall allow the Law Students to witness and observe Lok Adalats in session, subject to availability of rooms/space for the same.

7. The agreement becomes effective with immediate effect and shall remain valid for a period of three years.
8. The agreement may be terminated by either party with advance written notice of at least thirty(30) days.
9. The Agreement may be extended by mutual consent of the two Parties after the three years, and be renewed in writing.
10. The Agreement places no financial obligations or supplementary funding commitments on either party.


Now, this Memorandum of Understanding has witnessed as follows:-

IN WITNESS TO THIS, the parties have signed this Memorandum on the date mentioned above.




