It is hereby notified for information of all concerned that consequent upon the re-scheduling of Examinations as well as opening of New Academic Session, 2020-21, by Mizoram University (MZU) Notification No.14 of 2020 No.Exam/PC/1-2/16 Dated 3rd July, 2020, Admissin Notice issued vide No.C.31020/1/2011-MLC Dated 25th June, 2020 stands re-scheduled as under:

A. Third & Fifth Semester:

- (a) Admission can be taken for the Third & Fifth Semester during the 25th August – 3rd September, 2020.
- (b) However, Admission may be given after 3rd September with late fee of Rs.100/-
- (c) Academic Session will commence w.e.f. the 10th September, 2020.
- (d) All dues, including College's Bus fee, have to be cleared at the time of Admission.

B. First Semester:

- (a) Application Form for Entrance Test may be obtained online/offline till 3rd September, 2020.
- (b) Entrance test will be conducted on the 4th September, 2020 at 12:00pm.

The Questions will be in MCQ types, except, General English.

- (f) Selected Candidates will take admission during 7th – 9th September, 2020.
- (g) Selected Candidates should submit proper admission Application Form enclosing all documents as required.
