1. Matters relating to the Equity Initiative Fund.


At the invitation from the Chair, the meeting discussed the matters. After detail deliberation, the meeting made resolutions as under:

The meeting resolved to appreciate the fund utilisation and thank the SPD Officials and RUSA itself as well for giving us such a handsome amount of money just when the college needed it most.
